The TGSPDCL reserves the right where ever necessary to make queries with the bidder's bankers.</p>

Bidders who have On Hand/ executing 3Nos. LOI/Agreement for erection of new 33/11KV SS including structure and connected 33KV & 11KV line works in any of the TGSPDCL Zones (Master Plan, Rangareddy, Medchal & Rural) is not eligible to participate in the Bid. Further, Substation works which are under site dispute & switching station SS will also be counted as on-hand.
