NOTIFICATION CALLING FOR NOMINATIONS FOR APPOINTMENT AS MEMBERS OF TELANGANA ELECTRICITY REGULATORY COMMISSION (TGERC)

The Telangana Electricity Regulatory Commission was constituted vide G.O.Ms.No.3, dt.26.7.2014 with Chairman and two Members. Keeping in view the vacancy position of the Members in the Commission.

Hence, it is decided to call for nominations from suitable persons for the posts of two Members of the Telangana Electricity Regulatory Commission.

The appointments would be made in accordance with the following;

Qualifications, Term of Office and conditions of service:

- a) The Members of the State Commission shall be persons of ability, integrity and standing who have adequate knowledge of, and have shown capacity in dealing with problems relating to engineering, finance, commerce, economics, law or management.
- b) The Member of the State Commission shall not hold any other office.
- c) The Chairperson shall be the Chief Executive of the State Commission
- The Member shall hold office for a term of five years from the date he/she enters upon his/her office;
 - Provided that the Chairperson or other Member in the State Commission shall not be eligible for re-appointment in the same capacity as the Chairperson or a Member in that Commission in which he/ she had earlier held office as such provided further that no Chairperson or Member shall hold office as such after he/ she has attained the age of sixty-five years.
- (e) The salary, allowances and other terms and conditions of service of the Members shall be such as may be prescribed by the State Government. Provided that the salary, allowances and other terms and conditions of service of the Members, shall not be varied to their disadvantage after appointment.
- (f) Every Member shall, before entering upon his/ her office, make and subscribe to an oath of office and secrecy in such form and in such manner and before such authority as may be prescribed.
- (g) Notwithstanding anything contained above, a Member may-
 - (i) Relinquish his office by giving in writing to the State Government a notice of not less than three months; or
 - (ii) be removed from his/ her office in accordance with the provisions of section 90 of Electricity Act 2003.
- (h) Any member ceasing to hold office as such shall -
 - (a) not accept any commercial employment for a period of two years from the date he/ she ceases to hold such office; and
 - (b) not represent any person before the State Commission in any manner.

Explanation. - For the purposes of this sub-section "commercial employment" means employment in any capacity in any organisation which has been a party to the proceedings before the State Commission or employment in any capacity under, or agency of, a person engaged in trading, commercial, industrial or financial business in electricity industry and includes a director of a company or partner of a firm or setting up practice either independently or as partner of a firm or as an advisor or a consultant.

II. The nomination should contain the following:

- 2) Bio-data of proposed candidate containing the following details:
 - a) Name
 - b) Age & Date of Birth
 - c) Position now held
 - d) Educational Qualification
 - e) Details of posts previously held and experience in any of the field of Engineering, Law, Economics, Commerce, Finance, Accountancy or administration.

The mere submission of nomination does not confer any right to be appointed as Members of the Commission.
