Further to the letter vide reference 3<sup>rd</sup> cited, the following modified instructions are issued based on the suggestions made by the Govt. of India in improving the "Ease of doing Business" in the States and the assessment frame work for ranking the States in "Ease of doing Business" with a request to adopt the suggestions made by the Govt. of India to ensure that the Telangana State is ranked on high in the comparison.

For the implementation of action points suggested by the Govt. of India, the following instructions are to be followed.

- i) Only 2 documents are required from the applicant for obtaining electricity connection.
  - a) Ownership documents.
  - b) MoA / Partnership Deed.
- ii) The time required for release of electricity connection is as follows:
  - a) Within 15 days from the date of application where no extension of network is involved and payment of required deposits whichever is later.
  - b) 15 days from the date of submission of CEIG approval and payment of required deposits whichever is later where extension of network is involved.

All the Superintending Engineers/Operation are requested to adhere to the above instructions scrupulously.
