TELANGANA STATE SOUTHERN POWER DISTRIBUTION COMPANY LIMITED (TSSPDCL) was incorporated under the Companies Act 1956 as wholly owned State Government Company. The Company with Head quarters at Hyderabad is carrying out electricity distribution business and is catering the electricity requirements of 15 districts in Telangana State Viz:-Mahabubnagar, Wanaparthy, Nagarkurnool, Jogulamba-Gadwal, Narayanpet, Nalgonda, Bhongir-Yadadri, Suryapet, Medak, Siddipet, Sangareddy, Vikarabad, Rangareddy, Medchal-Malkajgiri and Hyderabad Districts.

Applications are invited from eligible candidates in prescribed proforma for filling up of Two (2) Nos. of posts of Chairperson/Consumer Grievances Redressal Forum (CGRF) in Southern Power Distribution Company of Telangana State Limited.

The area of jurisdiction of the CGRFs in TSSPDCL is as follows:

<u>CGRF-I (Rural):</u> Mahabubnagar, Wanaparthy, Nagarkurnool, Jogulamba-Gadwal, Narayanpet, Nalgonda, Bhongir-Yadadri, Suryapet, Medak, Siddipet and Sangareddy Districts. (Containing 11 TSSPDCL Operation Circles)

CGRF-II (GHMC): Hyderabad, Rangareddy, Medchal-Malkajgiri and Vikarabad Districts. (Containing 10 TSSPDCL Operation Circles)

The desirous eligible Candidates may submit the application in prescribed format well in advance not later than **26-02-2024**, addressed to the Chairman & Managing Director, TSSPDCL, Corporate Office, 6-1-50, Mint Compound, Hyderabad – 500 063, Telangana, India.

I. Eligibility:

1. Age: The applicant shall be a retired Officer and shall have attained a minimum age of fifty-five (55) years as on the date of publication of the advertisement for the vacancy.

2. Eligibility Criteria:

The applicant shall be:-

(i) a retired District Judge or a retired judicial Officer having served for 20 years in the State of Telangana;

(ii) a retired Chief Engineer(Electrical)/Chief General Manager (Electrical) of a Distribution/Transmission licensee in the State of Telangana having 20 years of experience;

(iii) a retired Chief General Manager(Accounts Services) from a distribution licensee of Telangana State having 20 years of experience.

Provided that, a retired Chief Engineer (Electrical)/Chief General Manager (Electrical) of a Distribution/Transmission Licensee / a retired Chief General Manager(Accounts Services) of a distribution licensee in the State of Telangana applying for the post of Chairperson of the Forum shall not have been in the employment in any capacity under, or agency of, the Distribution/Transmission Licensee on the date of consideration for the post of Chairperson of the Forum.

Provided further that, the applicant who has been appointed as Chairperson in other DISCOMs are not eligible for the post of Chairperson in any of the CGRFs in TSSPDCL.

3. Tenure:

The Chairperson of the Forum shall hold office for a period not exceeding three(3) years or till attaining the age of Sixty Five (65) years, whichever is earlier.

The Chairperson shall not be eligible for any extension of term except for such short periods not exceeding six(6) months as is necessary or expedient, with the prior approval of the Commission (TSERC) or as may be directed by the Commission to enable the appointment of successors.

4. Job profile:

The FORUM shall receive the complaints and process the same, shall call for the record, shall be heard in the presence of the complainant and issue necessary orders. The FORUM shall make sittings for hearing the complaints in the Operation Circles under the respective jurisdictions as per the schedule.

5. Emoluments:

- i. Consolidated Remuneration of Rs. 1,20,000/- (Rupees one lakh and twenty thousand only) per month without linking to the pension drawn by them and with 10% annual enhancement cumulative. They are not entitled for any Dearness Allowance and House Rent Allowance.
- ii. <u>Leave:</u> He/She will be eligible for Casual Leave and Earned Leave as admissible to the serving temporary Telangana State Govt. Servant. However, he/she will not be permitted for encashment of Earned Leave.

- iii. **TA & DA:** He/she will be eligible for TA & DA on official tours as applicable under rules of Telangana State Govt.
- iv. **LTC:** He/she will not be eligible for Leave Travel concession.
- v. He/she will not be eligible for pension and gratuity for the service rendered in the CGRF.
- vi. He/she will not be eligible for medical reimbursement.
- vii. **Vehicle:** He/she will be provided a vehicle for official use with a limit of 2500 Kms. and a monthly hire rate of not exceeding Rs.35,000/-.
- viii. **Mobile charges:** He/she will be eligible for mobile usage charges on par with the Officers of TSSPDCL.
- ix. One office attendant shall be provided to him/her.

No other benefits shall be extended to him/her during or after tenure or on his termination/relinquishment of the appointment.

II. SUBMISSION OF APPLICATIONS:

- 1. The applicants are required to go through the detailed notification and decide themselves as to their eligibility for this recruitment carefully before applying.
- 2. The applicants have to submit the application along with enclosures well in advance. Applications received after due date will be rejected. The TSSPDCL will not be responsible for the postal delay.
- 3. Applicants desiring to apply for both the posts of Chairpersons/CGRF-I & CGRF-II, separate application has to be submitted for each post.
- 4. Incomplete/in-correct/in-eligible application form will be summarily rejected. TSSPDCL under any circumstances will not entertain the information if any furnished by the candidate subsequently. Applicants should be careful in filling up the application form at the time of submission. If any lapse is detected during the scrutiny, the candidature will be rejected even though he/she comes through the final stage of recruitment process or even at later state.
- 5. The applicants should not furnish any false/tampered/fabricated information or suppress any material information while filling of the application form.

6. Mere submission of application and mere attending of interview does not confer any right on the applicant for appointment to the post of Chairperson/CGRF.

<u>Note:</u> Applicants satisfying the eligibility criteria will be shortlisted and shall be called for to attend the interview.

Other Instructions:

No Person shall be appointed and/or be entitled to continue as a Chairperson or a Member if he/she stands disqualified on account of his/her;

- a) Having been adjudged an insolvent;
- b) Having been convicted of an offence which, in the opinion of the Licensee, involves a moral turpitude
- c) Having become physically or mentally incapable of acting as such a member;
- d) Having acquired such financial or other interest as is likely to affect prejudicially his/her functions as a Chairperson;
- e) Having so abused his/her position as to render his/her continuance in office prejudicial to public interest;
- f) Having been guilty of proved misbehavior;
- g) Refusal or failure, without reasonable cause to discharge the functions for a period of at least three months; or
- h) Ceases to fulfill any of the conditions of his/her appointment as a Member.
